<sup>\*\*</sup> Focus sectors: Agriculture and food, energy, and water, sanitation and hygiene (WASH). Business ideas from the ICT sector that create impact in one of IAP's three focus sectors are also eligible to apply. Target countries: Cambodia, Ethiopia, Uganda, and Zambia.

<sup>\*\*\*</sup> According to EU regulations, a company in the EU may receive a maximum of €200,000 in public funding from European authorities during a three-year period. Sida as the donor of IAP applies the same rule to companies which are not based in the EU.
